## TERMS OF AGREEMENT

1. Artists are responsible for all their own possessions (including unsold artwork) while at their table. **Gryphon will not be held liable for lost or stolen possessions while an artist is at their table.**
2. Artists wishing to leave their table during Gryphon for any reason must inform either the Artist Alley coordinator or the Gryphon coordinator that they intend to leave. All possessions (including unsold artwork) will be held in custody of the respective coordinator. **Absolutely no artwork will be sold while the respective artist is away from their table, and Gryphon will not be held liable for any lost business during the artist's absence.**
3. Artists are free to take artwork commissions. All paid-for commissions are to be completed at a time agreed upon by both artist and client. **Failure to complete a paid-for commission by Gryphon of next year may result in the artist's prohibition from participation in Artist Alley at future Gryphon events.**
4. Artists have full right to refuse business to any client attending Gryphon.
5. Overnight lodging will be provided to artists in the University Centre during Gryphon. Artists wishing to stay overnight are advised to clear all possessions from their table by midnight of each night during Gryphon. Anything left on tables overnight **will** be guarded; however it is advised that artists cover up their tables. Please note that no beds are provided for overnight use.
6. Alternative art depicting gore, violence, nudity, and sexuality (including yaoi/yuri, hentai, etc.) are permitted for sale during Gryphon. **However, during daytime hours all artwork depicting gore and/or violence must be covered, and all artwork depicting nudity or pornographic material must remain covered at all times.** Gryphon maintains the right to deny the sale of any piece of artwork deemed questionable.
7. Interfering with the sale of other artists' artwork (e.g. through defacing, destroying, bashing or otherwise) at Gryphon will not be tolerated. **Anyone caught treating any artist or their possessions in a negative manner may be permanently removed from Gryphon.**
